
RCA-RUG Classification Tree

MaineCare residents are included in the rate setting case mix index calculation. MaineCare is determined by checking the MDS-RCA item A8a -MaineCare/state assistance. When completing the MDS-RCA, check with your billing office to verify sources of payment. Source of payment is coded as of the date of the assessment (MDS item A5.)
